Connecticut Foodshare CT-NAP Request



What is CT-NAP? Connecticut Nutrition Assistance Program

- State funding for the purchase of Connecticut-grown and Connecticut-sourced foods.
- Distributed to participating partner programs at no cost.

What we are requesting

Increased funding in the State budget for CT-NAP food purchases.

- In 2022, the state provided \$650,000
- In 2022, Connecticut Foodshare requested \$10 million
- In 2023, the state provide \$800,000
- In the 2024 legislative session, Connecticut Foodshare is requesting \$10 million

What do other states provide?

Among the states with food purchasing programs that support emergency food providers, Connecticut ranks near the bottom in spending.

- Massachusetts spends \$35 million
- New York spends \$34 million
- Only Texas spends less per capita than Connecticut.

Building Relationships: **How Your** Program Can Connect with Representatives

- Get to know your local and state elected officials
 - Help them understand food insecurity in YOUR community
 - Invite them to visit
- Connect with your member of Congress
 - They want to know what's happening in the community and how they can help

Building Relationships: Why it Matters

- State and local officials can help with needs your program faces
 - Facility improvements
 - Changes in local operations that can affect traffic and neighbor safety
 - Help with other issues like signage
- Congressional Representatives and State Representatives rely on the information we share about need in our communities when they are drafting legislation and budgets

Building Relationships: Next Steps

 Representation, there are tools to locate
 your State and Congressional
 Representatives
 - Consider an invitation to your State
 Senator or Representative to visit your site.
 - Know your service delivery numbers: your Network Relations Representative can help you with a summary report on pounds ordered and households reported.




